He talked about the trucks getting older and needing more repairs so he is looking to buy a demo truck rather than waiting for one to be built. Chief said they have hired an EMS Division Chief and are doing promotions within the department. He briefly talked about a new Mack cascade truck that will allow bottles to be refilled on scene. He said the Santa runs were done and were successful. No action taken.

The Board will receive an update/report from AGCM and/or the Building Committee regarding the Station 161 living quarters (Loop 1604), and recommendation/action concerning construction contract for completion of the project and any related item necessary recommended by the Building Committee for project completion.

Art Waterman of Waterman Construction and Garrett from AGCM were both present via telephone to give an update on the construction. Art spoke about continuing to work with CPS to get permanent power to the building. He said drywall is going up and the seal between the buildings is complete.

Motion by Director Cavazos to authorize an amount not to exceed \$230,000 for the December pay app. Seconded by Director Castillo. Motion carried 5/0.
