He said Judge Sakai would like to have trainings twice a year. Commissioner Cavazos suggested one training and one meeting on the ESDs to discuss things that might affect everybody. Chris Herrera said he would pass along that suggestion. No action taken.

The Board spoke briefly about different ideas. Chief Rodriguez said Rudy Khalaf would be able to help. This item will be tabled until next meeting when the new appointee will be present as well.
